## COOPERATIVE AGREEMENT

TUI University  
AND  
National Paralegal College

This agreement is entered into between TUI University, or hereinafter TUI, located at 5665 Plaza Drive, 3rd Floor, Cypress, CA 90630, accredited by the Western Association of Schools and Colleges, and National Paralegal College or hereinafter NPC, located at 6516 N 7<sup>th</sup>, Ste #103, Phoenix, AZ 85014 and accredited by the Distance Education and Training Council.

### INTRODUCTION

TUI and NPC recognize the desirability of NPC graduates to be able to transfer from NPC upon award of the Associate's degree program to the appropriate Bachelor's degree program at TUI. Students that have successfully completed the NCP Associate Degree in Paralegal Studies, will be able to transfer (GPA 2.0 or higher) into the TUI Bachelor of Science in Business Administration (B.S.B.A) Degree Completion or TUI Bachelor of Science in Business Administration (B.S.B.A.) with a concentration in Criminal Justice Administration.

### ADMISSION, TRANSFER, AND PROGRAM REQUIREMENTS

All TUI admissions, course transfer, and program requirement policies will apply as stated on the TUI website at: [www.tuiu.edu](http://www.tuiu.edu). Refer to the Colleges of Business Administration for detailed information.

### TERM

1. This agreement shall be for a term of three years from the date of the agreement. Unless terminated by either party prior to the end of the first term, the agreement shall automatically renew for an additional three-year term.
2. Either party may terminate this agreement with written notice to the other party. Such notice shall be given at least 90 days prior to the effective date of termination. In case of termination, students who have transferred from NPC to TUI prior to the termination date shall be afforded all rights referred to in this agreement for a period of two years after the termination date.
